This Schedule of Benefits shows your copayments and coinsurance for the covered services outlined in the Community Care *Member Handbook/Evidence of Coverage*. It also outlines any of your benefits that differ from those shown in the *Member Handbook/Evidence of Coverage*. The information in this document replaces any information in your *Member Handbook/Evidence of Coverage* that conflicts with it. This health plan **meets Minimum Creditable Coverage standards** and **will satisfy** the individual mandate that you have health insurance.

MASSACHUSETTS REQUIREMENT TO PURCHASE HEALTH INSURANCE:

As of January 1, 2009 the Massachusetts Health Care Reform Law requires that Massachusetts residents, eighteen (18) years of age and older, must have health coverage that meets the Minimum Creditable Coverage standards set by the Commonwealth Health Insurance Connector, unless waived from the health insurance requirement based on affordability or individual hardship. This health plan **meets Minimum Creditable Coverage standards** that are effective January 1, 2023 as part of the Massachusetts Health Care Reform Law. If you purchase this plan, you **will satisfy** the statutory requirement that you have health insurance meeting these standards.

The following apply to your Member Handbook/Evidence of Coverage:

#### **Out-of-pocket maximum**

There is a limit to your out-of-pocket costs each benefit period. This is called your out-of-pocket maximum. The out-of-pocket maximum includes coinsurance and copayments you pay. It does not include your plan premium. Your out-of-pocket maximum is \$1,500 per member/\$3,000 per family. Each member must meet the per-member out-of-pocket maximum unless the family out-of-pocket maximum applies. The family out-of-pocket maximum is considered met when any combination of members in a family reaches the family out-of-pocket maximum. Please note that once any one member in a family accumulates \$1,500 in out-of-pocket costs, that family member's out-of-pocket maximum is considered met, and that family member will have no additional out-of-pocket costs for the remainder of the benefit period.

#### Prescription medication out-of-pocket maximum

There is a limit to what you will have to pay for covered prescription medications you receive during the benefit period. This is called your prescription medication out-of-pocket maximum. Your prescription medication out-of-pocket maximum includes any coinsurance and copayments you pay for prescription medications. Your prescription medication out-of-pocket maximum does not include your premium charge or any costs you incur for health care services. Your prescription medication out-of-pocket maximum is \$750 per member/\$1,500 per family per benefit period.

#### Domestic partner coverage

You may include a domestic partner and his/her dependents under your family coverage. A domestic partner is defined as a partner of the same or opposite sex whom you have registered with your employer for eligibility for benefits, and have included under your family coverage for health insurance.

#### It Fits! <sup>™</sup> benefit

Your contract includes coverage for services provided under the It Fits!<sup>™</sup> program to a maximum of \$150.

# Addendum Pediatric Dental Services
